The first appearance of the surname Barrow in America occurred at Jamestown, Virginia, when one Thomas Barrow was listed among the dead in the year 1623. Early records indicate that many Barrow immigrants arrived in seventeenth century Virginia and soon spread throughout the state. There they established themselves as planters, and this tradition continued in later generations as they moved to the Carolinas and eventually to the fertile lands of Louisiana.

Due to one missing link, it is impossible to trace the direct ancestry of the Louisiana Barrows to the first of the surname in America. However, strong circumstantial evidence indicates that the original ancestor of this family was Thomas Barrow of Surry County, Virginia; a small landowner who died intestate in 1685. This Thomas had a son, Thomas, Jr., who moved to Southampton County, Virginia, about 1711 and settled a plantation on the Nottoway River. Thomas, Jr., acquired considerable landed property, had at least seven children, and died in 1763 at the advanced age of more than ninety years. Here there is a break in the record, and only surmise infers that one William Barrow who left Southampton County and settled in North Carolina was the son of Thomas, Jr.

The first proven record of the ancestors of the Louisiana Barrows is found in Edgecombe County, North Carolina. On December 29, 1747, William Barrow (I) purchased 640 acres of land on the north side of Cypress and Kehukee Swamps in that county. Five years later, he sold 320 acres of this property on Kehukee Swamp; the remaining half was eventually willed to his son, William Barrow, Jr.

William Barrow was married to Priscilla, surname unknown, and they had two children. Their daughter, Anna, married John Fort of Edgecombe County, North Carolina, and their son, William, Jr., married Olivia Ruffin of Northampton County in the same state. Little is known about William and Priscilla other than the fact that they purchased land in Edgecombe County, N. C., in 1747. In October, 1751, "William Barrow of Southampton County, Virginia" sold land on the east side of Fishing Creek, and it is supposed that this was the same William I who had acquired North Carolina property four years earlier.

About the same time that William was purchasing lands in Edgecombe County, one Thomas Barrow was also buying property there. Several early deeds are witnessed by Thomas Barrow and Mary, his wife. It appears that he was a brother of William, but substantial proof of this has not been found. In any event, Mary died early and her widower soon remarried. James Barrow (1757-1828), the grandfather of Chancellor David C. Barrow of the University of Georgia, wrote: "My father Thomas Barrow ... was born in Southampton County, Virginia in 1698 and when grown up and married moved from Virginia to

North Carolina on Fishing Creek about five miles above its Junction with Tar River in Edgecombe County, where his first wife (Mary) died and all his children except one by the name of Hosea. He then (my father Thomas Barrow) married my Mother whose name was Elizabeth Atkinson originally of Virginia also, by whom he had four children Jacob, James, Moses and Sally."

It is evident that William and Thomas Barrow, Jr.,

It is evident that William and Thomas Barrow, Jr., were friends and residents of Edgecombe County by 1751. We know that Thomas, Jr., was the son of Thomas and Elizabeth Barrow of Southampton County, Virginia, — a fact proven by the will of his father written in 1761 and probated two years later. Since William had died three years prior to the writing of Thomas Barrow's will in 1761, it is quite possible that he was a son of the elderly man who probably made a settlement with his widow and grand-children and had no reason to mention them in his will. Since Thomas, Jr., left Edgecombe for Onslow County, N. C., about 1759, shortly after William's death, one might surmise that the latter's demise had an effect upon this move.

In 1759, Halifax County, N. C., was formed from the oldest part of Edgecombe and much of the Barrow property automatically became a part of the new county. William died in 1758, leaving his widow, Priscilla; a son, William, Jr.; and a daughter, Anna, wife of John Fort. William, Jr., was not married at the time and Anna had only one child, Elizabeth, so it is reasonable to assume that their father was not an elderly man at the time of his death. On October 19, 1759, the widow Priscilla Barrow married Elias Fort in Halifax County, but they had no children.

On July 8, 1760, William Barrow, Jr. married Olivia Ruffin of Northampton County, North Carolina, and it was she who was destined to be the first of the family to settle in Louisiana. She was the daughter of Robert Ruffin and Anne Bennett, both of whom descended from distinguished Virginia families which had been prominent in Colonial affairs. After their marriage, William, Jr. and Olivia resided for about six years in Halifax County, North Carolina, during which time four sons were born. Their home was apparently on the same plantation that had formerly been owned by his father, William. It is interesting that when William, Jr. decided to sell this land, he advertised it in The Virginia Gazette, published at Williamsburg, Virginia, on June 6, 1766:

To be SOLD

A TRACT of LAND in Halifax county, North Carolina, on the south side of Roanoke river, about 20 miles below Halifax town, containing 420 acres, with a dwelling house, kitchen, and other out houses, two good apple orchards, up-

wards of 100,000 corn hills of fresh cleared land under a very good fence, a fine convenient spring, and about a mile from the river. The terms, which will be very reasonable, may be known by applying to me on the premises.

WILLIAM BARROW

One hundred acres of the above property, located on Cypress Swamp, was sold to Thomas Hunter of Northampton County, N. C., on December 29, 1766. The deed of transfer states that this tract "was devised to the said William Barrow by the last will and testament of his father, William Barrow, deceased." It was not long after the sale of this portion of his inheritance that William, Jr. and Olivia moved to South Carolina. On October 19, 1772, "William and Olivia Barrow of South Carolina" sold the remaining 320 acres of his plantation in Halifax County, N. C.

There is no record of the county in South Carolina where the Barrows lived, but it is believed that their five youngest children were born in that state. A family legend says that when South Carolina was overrun by the British, William, Jr. returned to North Carolina and settled at Tarboro in Edgecombe County. There is no record of his owning any property in North Carolina during the Revolution; however, if the tradition is correct, he may have resided at the home of his sister, Anna Fort, in Edgecombe. More probably, he did not return to North Carolina until the war was over. He had sold all of his North Carolina lands by 1772, and did not begin to acquire property there again until March, 1782, when he bought a plantation in Halifax County. At the time of his death in 1787, he owned more than 1,000 acres in North Carolina, as well as property in South Carolina.

Tradition says that William, Jr. was crippled and for that reason did not serve in the Revolutionary War. The name of Barrow was not uncommon in early North Carolina, however, and at least one William did serve on the colonists' side in that conflict. In recent years an erroneous claim has asserted that this was the William, Jr. who married Olivia Ruffin. A careful investigation of U.S. Pension Records reveals that the soldier William was the husband of Susannah Barrow, from an entirely different family and section of the state. There is also a tradition that William, Jr. was once the Sheriff of Edgecombe County, but this cannot be substantiated and appears in error. Another record indicates that it was William III, son of the above, who held this office in South Carolina. Neither of these claims has been verified, and all that we know definitely is that the position of sneriff in Colonial America was a distinguished one.

William Barrow, Jr. wrote his will in November, 1786, "being sick of Body, but of perfect sense and memory, calling to mind that it is appointed for all men once to die." He died at his home near Enfield in Halifax County, N. C., on January 27, 1787, and was buried on his plantation. His widow, Olivia, was loaned "the labour of six of my negroes, as she may make choice of, also all my stock of every kind, except what I may give away hereafter; also my household & kitchen furniture, likewise my plantation utensils during her natural life; likewise I lend my loving wife the land and plantation whereon I now live during her natural life." This home place was to be equally divided by his youngest sons, Ruffin and Bennett, upon the death of their mother. William III was made the guardian of his younger brothers until "they shall come of age," and he was given a plantation at the mouth of Beech Swamp. Robert Barrow was willed 200 pounds, while Bartholomew Barrow received 400 pounds. The daughters, Mary and Sarah, were each given a Negro girl and a colt. Any remaining portion of the estate was to be equally divided between the seven surviving children. Furthermore, the executors were directed to sell all of

his land in South Carolina and property in North Carolina at their discretion.

The executrix of William, Jr.'s estate was his wife, Olivia, and the executor was his son, William III.<sup>3</sup> They sold certain lands and slaves from the estate at various times following William, Jr.'s death. As late as 1793, they sold Robert Barrow eighteen slaves for 192 pounds and 15 shillings, and also transferred thirteen Negroes to Bartholomew Barrow.

The first U. S. Census of 1790 lists Olive Barrow of Halifax County, N. C., as the Head of a Family which consisted of "3 Free White females, including heads of families; 2 Free White males under 16; 1 Free White male of 16 and upward." She also owned 45 slaves — a substantial number for that locale and era. Her household was made up of herself, her daughters Mary and Sarah, and sons Bartholomew, Ruffin, and Bennett. Robert Barrow, the eldest son, had married Mary Haynes before 1790, and he is listed separately in the Census as the owner of nine slaves. William III was not as yet married and had either moved to South Carolina to oversee property there or was perhaps a resident of Edgecombe County, for he apparently lived there after his marriage. We know that, in 1795, "William Barrow of Edgecombe County" sold property on Fishing Creek in Halifax County to James Slatter.

Olivia Ruffin Barrow continued to live in Halifax County for approximately ten years after her husband's death. She appears to have been an intelligent manager, for she reared her younger children alone. At the time of their father's death, Mary was fifteen, Sarah was thirteen, Ruffin was eleven, and Bennett was only nine years of age. As her children matured, Olivia began to note the great financial opportunities which lay in the new Southwest, where land holdings could be increased substantially. Tales of large land grants and the profits to be made from the increased production of cotton must have come back to North Carolina frequently.

The invention of the cotton gin in 1793 and the Industrial Revolution in England induced an ever-increasing demand for cotton, and it is highly probable that Olivia and her children could foresee the enormous profits to be made from raising this staple crop. Migration was decidedly affected elsewhere in the United States by the need for more and more cotton, and the 1790's saw large numbers of settlers moving out from the seaboard South into new Vast unsettled areas of the public domain were available only for the asking, and this offered an irresistible invitation to the economically inclined citizens of the South. Virginia and North Carolina led other states as colonizers of the Lower South by a wide margin, and both sent large numbers of agricultural opportunists into the Louisiana Territory. This large exodus continued well into the nineteenth century, and was occasioned to no small degree by the exhaustion of plantation lands in the earlier Southern colonies.

The farsighted Olivia, after consulting her children, decided to move to the Southwest about the year 1797. Accordingly, the Barrows sold certain properties in North Carolina and prepared to journey overland to Tennessee. Olivia, her sons Robert, William III, and Ruffin, and her daughters Mary and Sarah, all moved to Sumner County. Tennessee, and remained there for more than two years. It appears that the Barrows intended to make Tennessee their permanent home. Of Olivia's children, only Bartholomew and Bennett chose to remain in North Carolina. In 1798, "Ruffin Barrow of Sumner County, Tennessee, and Bennett Barrow of Edgecombe County, North Carolina," sold 640 acres of land in Halifax County, N. C., to their brother, Bartholomew, which was "their share in the estate left by their father William Barrow." This was the home place, and apparently had been given by Olivia to her two youngest sons at the time that the family left North Carolina for Tennessee.

Ruffin Barrow was the only unmarried one of the five children in Sumner County, and he died there on December 16, 1799 — just two days after the death of George Washington. It is thought that he was buried at Gallatin, Tennessee. Perhaps his death gave the family an incentive to leave Tennessee, and perhaps too, the planting opportunities in Sumner County were less auspicious than those further South. In any event, they decided to make another move.

Sometime in 1800, the Barrow family set out once again on another journey which was to take them to the Louisiana Territory. They probably did not leave Sumner County until the autumn of 1800, when Olivia Barrow and her three children, Robert, William III, and Mary Barrow Lane, made up a wagon train headed for Natchez. The latter two had children with them, and it is thought that their cousins, the Forts, were also in this group. While there is no proof, circumstantial evidence indicates that Olivia's daughter, Sarah, remained with her husband, John Dawson, and children in Tennessee, until a few years after the turn of the nineteenth century.

The Barrow caravan must have made a colorful procession as it travelled slowly over the treacherous Natchez Trace into the rich Louisiana Territory. At the head of the group were the stalwart grandmother, Olivia, and her son, William III. According to legend, they came in thirty covered wagons, bringing their slaves, gold, and prized household furnishings with them. The entourage arrived in Natchez during the latter part of 1800, and there they waited for permission from the Spanish authorities to enter the territory of Neuva Feliciana — that fertile section of West Florida where they intended to settle.

While still in Natchez, four days before the Christmas of 1800, a third child was born to William III and Pheraby Hilliard Barrow. He was named William Ruffin Barrow, and had the distinction of being the first of the family to be born in the Louisiana Territory. It is believed that the Barrows entered the Feliciana country shortly after the birth of this little boy. Thus the trek which had begun in North Carolina approximately four years earlier finally culminated in Louisiana, with several births and at least one death along the way. It is doubtful that the family realized what an auspicious step it had taken, for none could have known that they would soon be leaders in a pageant of plantation life which would stretch out colorfully for the next sixty years. And much of the credit for this farsighted move goes to Olivia Ruffin Barrow, the pioneer.

Olivia seems to have lived with her son, William III, when they settled in Feliciana at a place called White House. She died during the spring of 1803 and was interred in the family cemetery at Highland, where a stone shaft was erected over her grave (Plate 29). While she lived only slightly more than two years in Louisiana, she saw her children become firmly rooted in Feliciana, and must have been able to envision the success which awaited them there.

Olivia Barrow's will, dated October 29, 1802, is on file in the courthouse at Woodville, Miss., and is signed Olive Barrow. It is as follows:

In the Name of God, Amen.

I, Olive Barrow, of New Feliciana, 4th District, being sick of body, but of sound sense and memory do ordain this my last will and testament as followeth:

I bequeath my soul to God that gave it and my body to the earth to be there decently buried according to the directions of my executors hereafter named, and as for what worldly estate it has pleased God to entrust me with, it being in the limits of the United States in the Mississippi Territory, I give, devise and bequeath in the following manner: First, I will that all my just debts and funeral charges be satisfied and paid.

Item—I give and bequeath unto my son, Robert Barrow, nine negroes, named by the following names: Rachel. Tiller, Charity, Lucy, Isham, Plinach, Archer, Joe and Isaac. I also give to him all the money that the P. negro has hired for since the year ninety-seven to this date I also give him three other negroes named by the following names: Pomp, Harry and Tom, and \$800.00. All of the above property I give to him, his heirs and assigns forever. The remainder part of my negroes that I shall hereafter give away I wish to be hired out at the direction of my executors until they earn money enough with the money due me for their past hire to satisfy the legacies I shall hereafter give away.

Item—I give and bequeath unto my son, Bennett Barrow, \$1500.00, to him, his heirs and assigns forever.

Item—I give to my son, Bartholomew Barrow, \$900.00, to him, his heirs and assigns forever.

Item—I give and bequeath unto my daughter, Sarah Dawson, one feather bed and furniture, to her, her heirs and assigns forever.

Item—I give and bequeath unto my granddaughter, Patsy Lane, three negroes, viz., Charles, Sue, and her child, Edmond, to her, her heirs and assigns forever.

Item—I give and bequeath to my granddaughter, Olive Ruffin Lane, two negroes, Nat and his wife, Lily, to her, her heirs and assigns forever.

Item—I give and bequeath to my granddaughter, Nancy Ruffin Barrow, my negro fellows, Joe and Siller, to her, her heirs and assigns forever.

Item—I give and bequeath unto my grandson, Robert Hilliard Barrow, two negroes, viz., my negro boys, Dick and Rheney, to him, his heirs and assigns forever.

Item—I give and bequeath unto my grandson, Ruffin Barrow, five negroes, viz., my negro, Cay Nelson, my negro woman, Violet, and her three children, Hasty Diner and Gin, to him, his heirs, and assigns forever.

Item—I give and bequeath unto my grandson, William Barrow Lane, one negro girl, Violet, and \$300.00, to him, his heirs and assigns forever.

Item—I give and bequeath unto my grandson, Joseph John Lane, my negro girl, Doll, and \$300.00, to him, his heirs and assigns forever.

Item—I give and bequeath unto my son, William Barrow, my negro fellow, Dick, to him, his heirs and assigns forever.

Item—I give and bequeath unto my daughter, Mary Lane, my negro woman, Dinah, to her, her heirs, and assigns forever.

Item—I give and bequeath unto my son, Robert Barrow, \$650.00, the money my negro fellow, Don, sold for, to him, his heirs and assigns forever.

Item—I give and bequeath unto my daughter, Mary Lane, all the remainder part of my estate that I have not before given away, to her, her heirs and assigns forever.

Lastly, I hereby appoint Robert Barrow and William Barrow, executors of this my last will and testament, revoking all former wills heretofore made by me.

In witness whereof, I hereto set my hand and affix my seal this twenty-ninth day of October, one thousand eight hundred and two.

(Signed) Olive Barrow

Declared to be the last will and testament of the testator in presence of Messrs. William Hunter, Henry Hunter, Jr., William Fort, John Fort.

Olivia Ruffin and William Barrow, Jr. were the parents of nine children — six of them settled in Louisiana, and five became the progenitors of families who have left many descendants:

I. WILLIAM BARROW (b. November 29, 1761-d. November 27, 1762)

ROBERT BARROW (b. February 18, 1763-d. May 29, 1815) married Mary (Polly) Haynes circa 1787 in Halifax County, North Carolina. He became one of the very large planters in Feliciana Parish, and early records indicate that he acquired much property there shortly after he arrived in Louisiana with his mother and other members of the the family. He was buried at Highland and his widow survived him for many years, eventually living at Green-wood, the home of his nephew, William Ruffin Barrow. She was buried at Greenwood. Robert and Mary Haynes Barrow had no children. The Polly Barrow Creek in West Feliciana was named for her.

III. WILLIAM BARROW III (b. February 26, 1765—d. November 19, 1823) married Pheraby Hilliard (b. February 11, 1775-d. October 10, 1827) on June 26, 1792 in North Carolina. He built the house at Highland, and they became the parents of nine children. This family figures in the text.

IV. BARTHOLOMEW BARROW (b. October 16, 1766-d. February 15, 1852) married (1) Ascension Slatter (d. 1803) on May 11, 1797 in Halifax County, North Carolina (2) Mrs. Bethia Brantley (b. 1777—d. February 17, 1843) and married circa 1804 in North Carolina. He and his second wife came to Louisiana in 1820 and settled on the plantation later known as Afton Villa. He had four children by the first marriage, and two by the second, all of whom figure in the text.

ANN BARROW (b. September 11, 1768-d. before 1786). Unmarried.

VI. MARY BARROW (b. May 16, 1771-d. July 1822) married David Lane (d. 1812) circa 1791 in Halifax County, North Carolina. They lived at Deer Run Plantation in West Feliciana and became the parents of seven children, who figure in the text.

VII. SARAH BARROW (b. May 14, 1773-d. February 17, 1816) married John Dawson (d. circa 1813) circa 1797. They became the parents of three children and she lived at Solitaire Plantation in West Feliciana. This family figures in the text.

RUFFIN BARROW (b. April 9, 1775-d. December 16, 1799). He died when the Barrows were living in Sumner County, Tennessee, and is thought to have been buried at Gallatin. He was not married.

BENNETT BARROW (b. June 22, 1777-d. July 22, 1833) married Martha Hill (b. circa 1780-d. 1829) circa 1801 in North Carolina. They came to Louisiana in 1818 and settled on Rosebank Plantation. They had six children, who figure in the text.

### Notes

(1) This quotation comes from a preface to the diary of James Barrow in which the author gives certain genealogical information on the early ancestors of his family. Portions of this diary (including the quotation used in the text of this article) are in typewritten form at the University of North Carolina Library, Southern Historical Collection, Chapel Hill, N. C. This data is all included under the title of "Record of the Barrow Family," prepared by David C. Barrow of Savannah, Georgia, in October, 1930.

(2) Olivia Ruffin Barrow signed her will Olive and seems to have been called by this shortened form of the name, which was probably pronounced "Oleeve." However, her tombstone is marked Olivia, thus confirming the correct form of her given name. No portrait of her or her husband has survived. For a brief history of the Ruffin family see the Appendix.

(3) The will of William Barrow, Jr. is recorded in Book 3, p. 118, Halifax County Courthouse, Halifax, North Carolina. It is interesting to note that it was William Barrow III, rather than his older brother, Robert, who assumed the role as "Head of the Family" after his father's death. It is believed that Robert was married at the time of William, Jr.'s demise, so this is a plausible explanation for the choice of William III as executor, for he was the eldest son living at his parent's home.

(4) As the house at Highland (then called Locust Grove) was not completed at the time of Olivia R. Barrow's death, it is

(4) As the house at Highland (then called Locust Grove) was not completed at the time of Olivia R. Barrow's death, it is possible that she was interred elsewhere and her remains later moved to the Highland cemetery. An old memoir written by her granddaughter, Martha Barrow Turnbull of Rosedown, infers this.

Isaac Barrow's father, Thomas Barrow, was a linen draper by trade. Thomas married Ann, daughter of William Buggin of North Cray, Kent in 1624 and their son Isaac was born in 1630. Ann died in 1634 and Thomas sent Isaac to live with his grandfather.

Thomas remarried within two years and it is suggested in [5] that this may have been an attempt to get his son back from his father, who was said to be spoiling young Isaac.

Thomas planned for Isaac to become a scholar while still a child. He sent Isaac to Charterhouse and paid twice the regular fee to get special attention for Isaac. However Isaac did not receive this attention and acquired the reputation as a bully while his education suffered. When Thomas heard of this, he transferred Isaac to Felstead, Essex in 1640 where the headmaster had a reputation for strict discipline. Here Isaac made rapid progress, both in developing his character and in learning. At Felstead Barrow learnt Greek, Latin, Hebrew and logic in preparation for University. After he had been at Felstead for two years, Issac's father incurred loses of £1000 due to the Irish rebellion and was unable to pay Isaac's fees. However, the headmaster, realising Isaac's potential, took him in and later appointed him as a tutor to Thomas Fairfax.

In 1643 Barrow was admitted as a foundation scholar at Peterhouse, Cambridge. His uncle was a Fellow of Peterhouse at the time and when his uncle lost his post due to his Royalist views, Barrow went to Oxford where his brother had become the King's Linen Draper. However there was an uprising against Royalty and Oxford came under siege.

In 1644 Barrow went to London where he was supported by Thomas Fairfax. However, Fairfax soon ran out of money and left Isaac destitute. Barrow accompanied a former school friend, who promised to support him, to Trinity College, Cambridge. Barrow enrolled in 1646 and performed menial duties in return for instruction with poor board and lodging. His friend supported him for six months before he left but, by this time, the siege of Oxford had ended and Barrow made contact with his father who helped support him.

Duport, the Regius Professor of Greek at Cambridge, tutored Barrow without taking any fees, both due to Barrow's talent and that both were royalists. Under Duport, Barrow studied Greek, Latin, Hebrew, French, Spanish, Italian, literature, chronology, geography and theology. Also at Cambridge at this time it was usual for students to learn some mathematics, either in their second or third year. Barrow studied arithmetic, geometry and optics and, like all students of the time, was encouraged not to specialise in a subject such as mathematics before graduating.

Barrow graduated in 1649 and successfully competed for a college fellowship in the same year. He gave a speech in which he praised the teaching of the classics but criticised the lack of mathematics and science. He started studying mathematics in depth immediately after his graduation. His enthusiasm and willingness to teach enabled him to attract enough people to the subject to help begin to lay the foundations for studying mathematics at Cambridge.

In 1652 Barrow graduated with his M.A. In 1654 he defended the University in a speech in which he spoke of the importance of learning Greek, Latin and literature for the purpose of acquiring a firm basis for learning. He also praised the advances the University had made in subjects such as Arabic, modern languages such as French, Spanish and Italian, mathematics and science. He ended his speech requesting [5]:-

... fellow students to persevere in the study and practice of moral philosophy.

Barrow had taken an oath to study divinity when he was admitted as a fellow, and, after briefly studying medicine, he began studying divinity again. His study of church history led him to astronomy which in turn led him to study geometry. He taught himself geometry, writing a simplified edition of 's *Elements* which was printed in 1655 and remained the standard textbook for half a century.

During this period Barrow was appointed to the college lectureship in Humanity. While in Constantinople Barrow spent much time studying divinity and in particular the local Greek Church. In some financial difficulty, Barrow began his return journey at the end of 1658. On the journey home the ship docked at Venice where it caught fire and all Barrow's possessions were lost. He then headed back through Germany and Holland, arriving in Cambridge in September 1659.

Barrow graduated in 1649 and successfully competed for a college fellowship in the same year. He gave a speech in which he praised the teaching of the classics but criticised the lack of mathematics and science. He started studying mathematics in depth immediately after his graduation. His enthusiasm and willingness to teach enabled him to attract enough people to the subject to help begin to lay the foundations for studying mathematics at Cambridge.

In 1652 Barrow graduated with his M.A. In 1654 he defended the University in a speech in which he spoke of the importance of learning Greek, Latin and literature for the purpose of acquiring a firm basis for learning. He also praised the advances the University had made in subjects such as Arabic, modern languages such as French, Spanish and Italian, mathematics and science. He ended his speech requesting [5]:-

... fellow students to persevere in the study and practice of moral philosophy.

Barrow had taken an oath to study divinity when he was admitted as a fellow, and, after briefly studying medicine, he began studying divinity again. His study of church history led him to astronomy which in turn led him to study geometry. He taught himself geometry, writing a simplified edition of 's *Elements* which was printed in 1655 and remained the standard textbook for half a century.

On the journey home the ship docked at Venice where it caught fire and all Barrow's possessions were lost. He then headed back through Germany and Holland, arriving in Cambridge in September 1659.

When he arrived back at Cambridge there had been many political changes due to the restoration of Charles II. The Professor of Greek voluntarily resigned in recognition that there were others who were better suited to the position - one of these people being Barrow himself. Duport was offered the post that he had been forced out of six years earlier, but he declined the offer. This left the way open for Barrow who, with no opposition, was elected to the position that many felt should have had years before. As Professor he received £40 per year and was not allowed to hold any other positions inside the College or University. He could not receive any income from his College Fellowship which made his financial position very difficult. Barrow campaigned for professors to receive benefits from their College Fellowships, if they held one, and his campaign was successful. In his annual speech after his first year he encouraged students to concentrate on their own private study and not on the lectures Barrow's interest in mathematics and his small income made the position of Professor of Geometry at Gresham College, London appear very attractive when it became vacant in 1662. He could also hold this chair while continuing as Professor of Greek at Cambridge. He was elected in mid-summer 1662 on a salary of £50 per year. At Gresham he taught geometry for two hours a week, one hour in English and the other in Latin. Barrow took his duties very seriously. He intended publishing these lectures, but he lent them to a friend who subsequently lost them. Topics covered included 'projection of spheres' and 'perspectives'.

Barrow became one of 150 scientists who were elected a Fellow of the Royal Society on 20 May 1663 at one of the first meetings of the Society. However his contribution to the Society was minimal and this could well have been influenced by the relation of the Society to the universities. The Society tried to appoint him to the Astronomical and Optical Committee and to the committee responsible for [4]:-

... collecting the phenomena of nature hitherto observed and all experiments made and recorded.

However this did not increase his contribution and, with his dues unpaid, the Society considered expelling him.

In the summer of 1663 the position as Lucasian Professor of Mathematics was created at Cambridge thanks to an endowment left by Henry Lucas. Barrow was an obvious choice for this position and he relinquished the Greek chair for the mathematics because, he explained, of his greater interest in mathematics than Greek, because less work was involved, and that it had always been his intention to hold the Greek chair temporarily.

In the spring of 1664 Barrow delivered the first six of his mathematics lectures which consisted of basic material. In the autumn he delivered nine more lectures and, in the spring of 1665 the first five of his geometrical lectures. After giving a short course on which consisted of four lectures the University had to close due to the plague. When it re-opened in April 1666 Barrow delivered another eight lectures but after June there was another outbreak of the plague. The university re-opened for the second time in Easter 1667 he gave further geometry lectures before delivering of his optics lectures in the 1668-9 session. Isaac attended these lectures and had many private discussions with Barrow about the work. took much encouragement from these sessions with Barrow and they influenced his work greatly.

John published most of Barrow's lectures: Lectiones Opticae was published in 1669, Lectiones Geometricae in 1670 and Lectiones Mathematicae in 1683. Barrow did not prepare his work for publishing, and others undertook this task. Most of Barrow's mathematics had been done over the years 1663 to 1669. A look at these three books show the extent of his work. Lectiones Mathematicae were lectures designed to revive interest in mathematics at Cambridge while trying to point it in a new direction by introducing modern techniques. He tried to classify the different branches of mathematics arguing that algebra is not part of true mathematics and should be considered to be logic while [5]:-

Geometry is the basic mathematical science, for it includes arithmetic, and mathematical numbers are simply the signs of geometrical magnitude.

In the later lectures he covered such topics as divisibility, congruence, equality, time and space. The final lectures cover measurement, proportion and ratio.

The Lectiones Geometricae probably represent work which Barrow studied while at Gresham. They contain the important work on tangents which was to form the starting point of 's work on the calculus. Barrow stated the main two aims were [15]:-

... first, to investigate tangents without the trouble or wearisomeness of calculation and, second, to determine the dimensions of many magnitudes quite quickly by means of their tangents ...

The Lectiones Opticae were more theoretical than practical, which was unusual for his time. The content is mainly geometrical optics and he states the main problem which the lectures are aimed at answering [4]:-

To define the image of a point after any reflection in a plane and spherical surface ...

In 1669 Barrow resigned from the Lucasian Chair to allow to take over and did no further mathematical work. Barrow was appointed as Royal Chaplain to Charles II at Salisbury in 1670, then, in February 1673, Charles II awarded Barrow the Mastership of Trinity declaring him to be the best scholar in England. While Master of Trinity, Barrow was occupied with two major issues. The first of these was to limit the amount of Royal interventions and secondly the building of the Wren library. On the first of these issues he had some success while on the second he spent much time and effort on generating interest in the project and the necessary funds. However he did not live to see the result of this work. In April of 1677 Barrow travelled to London where he contracted malignant fever. He tried to cure it by fasting and taking opium, a formula which had previously worked for him while ill in Constantinople. However he died and was buried a few days later at Westminster Abbey.

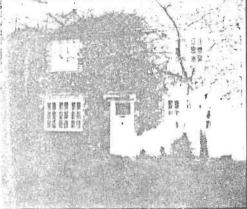

### Thomas de Barewe

Thomas de Barewe held the Manor of Barewe for Sir William Marshal on the orders of the Abbott of St. Edmunds Abbey. Thomas would have been tesponsible for the smooth running of the village and, most importantly, seeing that the taxes were collected.

### Mande de Passelewe

Thomas de Barewe's daughter Maud married Hamond de Passelewe, whose ancestor, Ralph de Passelewe, rebuilt the Barewe Church with stone. He obtained a grant of free warren from Henry III. Maud gave Sir William Giffard the part of Barewe called Alderfield on his marriage to her daughter Katherine.

### Katherine Giffard

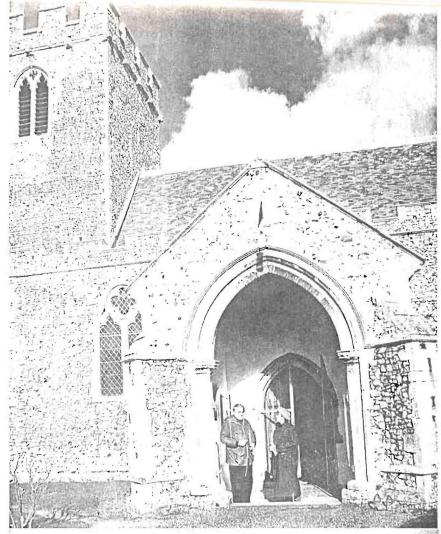
In 1242 it must have caused great excitement, and perhaps some apprehension, in the village when William rode into Barewe with his Squires and men at arms for his marriage to Katherine. In 1267, William, jointly with Maud Passelewe, was granted a charter to hold a market and fair.

In 1286, William had Barewe Hall built, making Barewe a very busy place with plenty of work for the Villeins and Freemen.

The King also rewarded Walter Giffard with 107 Manors and Lordships in England, and made him Justicair over England in 1085, to act for the King when he was abroad.

### Badlesmere & Despenser

A transaction took place in 1321 between Katherine and the Countess of Gloucester, the widow of Earl Richard of Clare, stating that Barewe became the property of Bartholmew, Lord Badlesmere, Badlesmere joined

the Earl of Lancaster in a revolt against King Edward II, was defeated at Boroughbridge on 17 March 1322, and then executed.

Barewe was then given by King Edward II to Hugh Despenser, a favorite of the King who rode with him against the rebellious barons. He held the Lordship of Barewe for four years "until the government collapsed and Hugh Despenser was executed.

Barewe Manor was returned by Edward III to Elizabeth, widow of Badlesmere. The Manor passed to her daughter Margaret, whose daughter Elizabeth married Richard le Despenser, son of Sir Philip.

### The Wentworths, 1434-1540

Le Despenser's daughter married Sir Roger Wentworth, whose family held the Manor until it was sold to Sir Clement Heigham in 1540.

The Heighams, 1540–1693 Sir Clement Heigham was an ardent supporter of Mary I and was knighted by the Queen's hosband, Philip II of Spain. His son John Heigham had the honor of having Queen Elizabeth I stay at Barewe Manor during her Progressions through Suffolk.

### The Herveys, 1693-1994

On 12 April 1693, Sir John Hervey bought the Sheep Courfe and the Manor of Barewe for the sum of £1,080. The Hervey Family acquired fatms and a great deal of land in Barewe. It was around this time that Barewe began to be called "Barrow." Lady Mary MacRae, a descendant of the Herveys, still lives in Barrow, at Hatchery House.

Another descendent, the most honorable Frederick William John Augustus Hervey, the Seventh Marquess of Bristol, sold the Lordship of Barrow (along with two other Lordships)

In 1991, on December 14, the Lordship of the Manor of Barrow was conveyed to Kathryn Falk. ■

# The History of the Cordship



I thought you would be interested Dear Readers: in knowing that as the Lady of Barrow, I am intimately involved in my local history. As you can see from the following questions I've received, The Lordship of Barrow has a very rich past.

The Lordship of Barrow is not only picturesque but has profitable rentals. (I can claim yearly rent for each telephone pole on the manorial wastes!) The drive is only 11/2 hours from London, as Barrow is between Newmarket and Bury St. Edmunds. You can see the spires of Cambridge in the distance. And Barrow comes with a rare privilege, the historic right to hold markers and fairs.

Since I one day envision a Romance Festival in Barrow and "A Fair To Remember," it's a perfect place.

dispensing "high justice," the power to inflict death in his courts.

Historians are also agreed that the Normans institutionalized the Manorial System in the Doomesday Book, compiled for William the Conqueror in 1086 and listing 13,418 Manors and their owners.

The Doomesday Book was an inventory of the wealth of the new kingdom and, as such, is still a Government document. It is housed at the Public Record Office where it is known as Public Record No. 1.

Throughout the Middle Ages, the English nobility was a caste whose power was based on the ownership of land through the Manor. Their peerages, unlike

those on the continent, were purely honorific and they lost them if they lost their landed status.

WHAT IS A LORDSHIP OF THE MANOR?

Lordships of the Manor are the oldest titles in England and pre-date the Norman Conquest, begun by William I at the Battle of Hastings in 1066.

Historians are not agreed on how the word Manor originated. It has been suggested that it was a French import, manoir, or perhaps even older, from the Latin, manerium. Nor ate historians sure whether it was a purely Saxon concept, its origins lying in the need for selfdefense down the east coast against succeeding incursions by Germanic tribes and later Vikings.

They are agreed, however, that by the 11th century, the Manor was the pivot of the Feudal System.

By the reign of Edward the Confessor (1042-66) the Lord of the Manor (be he the local leader, or some great suzerain, such as Earl Godwinson of Mercia) was the most important person in village affairs, whether it be collecting taxes for the King or

### HOW OLD IS THE LORDSHIP OF BARROW?

Long before recorded time people settled in Barrow (known as Barewe before being Anglicized), which was on a hill and thus gave a good viewallowing for early warning when strangers were about. The peak of the hill was constructed into the shape of a bowl to encourage the collection of rainwarer and form a dell, providing good conditions to support a community.

By the 12th century the village had become more sophisticated. It was less than a day's ride to the main Abbeys, Bury, Theford and Ely. By the 15th century it was quite convenient to travel to London, Kings Lynn or Ipswich.

It is not clear how much time the Great Families spent in Barewe; it was the way of life at the time for nobility to travel to each of their Manors in turn to use the riches of the estates. Barewe would have been looked after by the

Bailiff most of the year.

The earliest record of Barewe was made in 950 by Picot Sheriff of Cambridge, who held Barewe for Edward the Confessor.

By the time of the Doomesday Book in 1066 the village had grown. It was then owned by William the Conqueror, and consisted of: 15 Villeins, 10 Smallholders, 1 Slave, 3 Ploughs, 1 Mill, 1 Freeman with 30 acres, 60 Goats, 100 sheep, 40 pigs, and a wooden church with 17 acres of Freeland. Size: I. League in length by 8 Furlongs. As a whole it was valued at £20.00.

Located near Bury St. Edmunds, West Suffolk, this Lordship is extensive, covering a freehold of some 2,677 acres, including the historic right to Market and Fair, granted by Henry III in 1267.

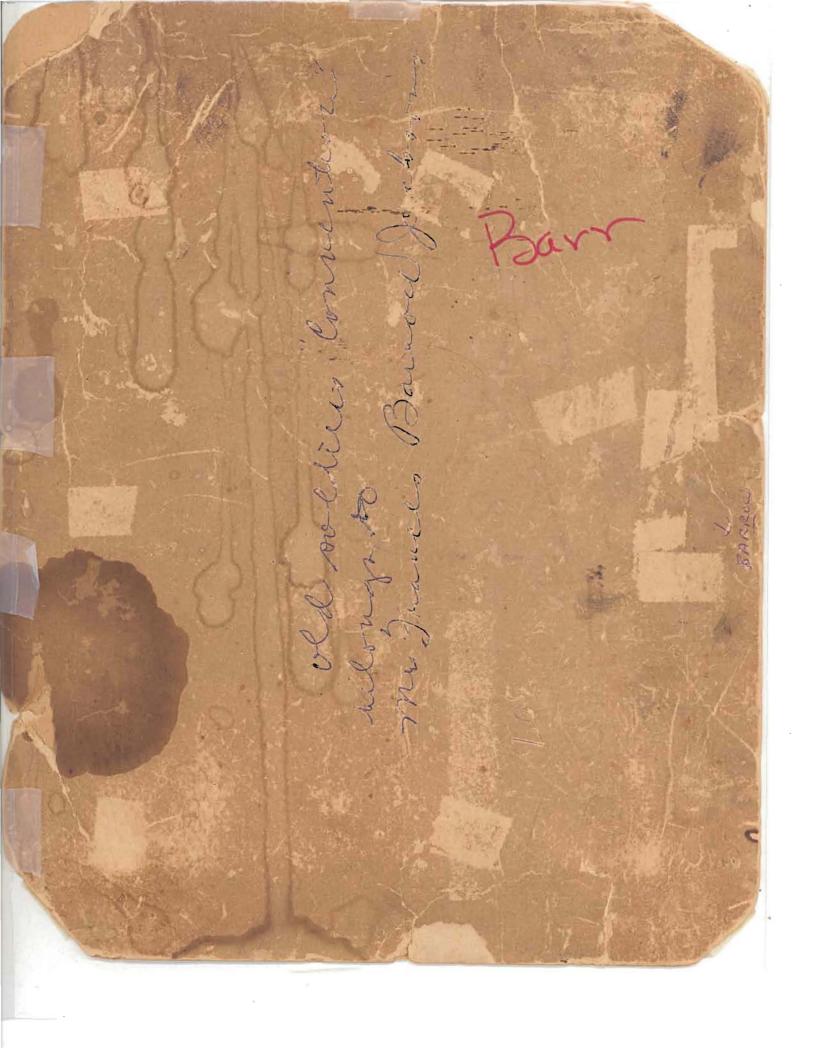

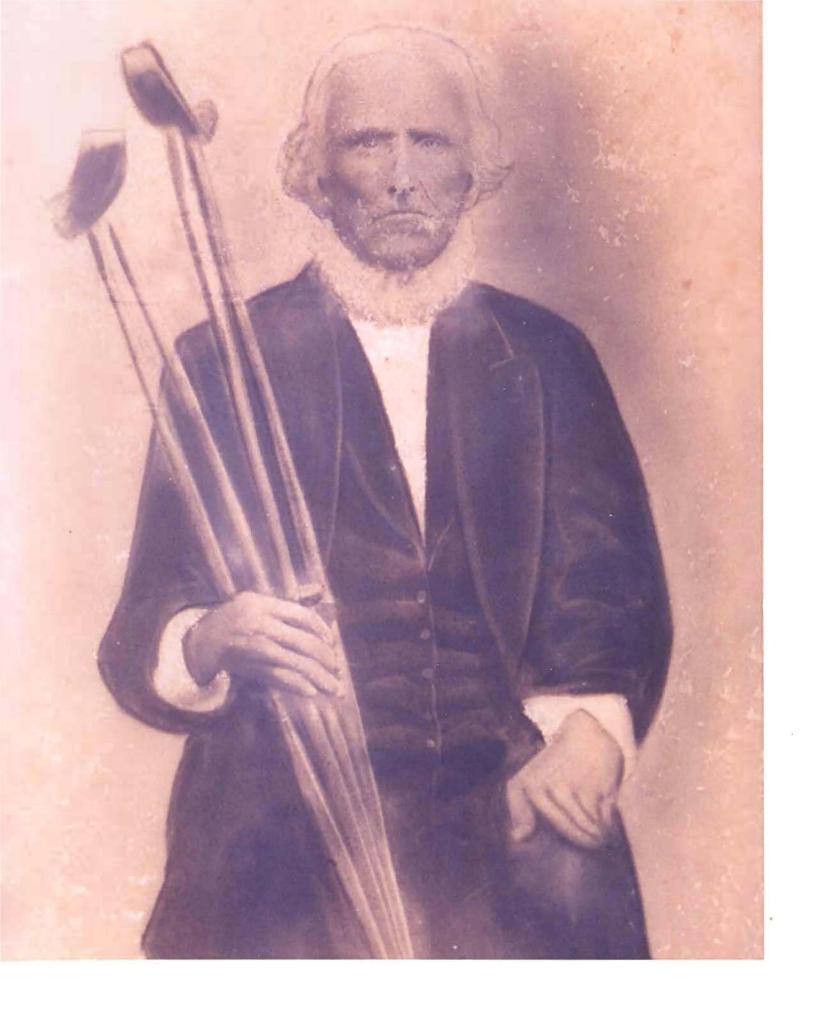

### A Brief History of Gabriel Smith Sr. and Some of His Descendants

Gabriel Smith, Sr., was born in what is now Montgomery County, NC, on December 12, 1764. Little is known of his family, but his father may have been the John Smith of Little River who had business dealings with Richard Downs. It is more probable that his father was the William Smith who lived adjacent to him when he migrated to Georgia.

As a fifteen year old boy, in August 1780, he entered the militia under Capt. Thomas Childs and marched to join Gen. Gates at Camden. They did not reach there before the battle and were discharged for furlough. In 7 days he returned to service and was marched to Mars Ferry where there was a skirmish in which Capt. Childs was wounded in the arm. Under the command of Capt. Samuel Pond they were defeated in a skirmish at Bettises Bridge on Downing Creek and returned home. After a few days they were reinforced and returned to action where he was taken prisoner of war in the fall of 1781. After about three weeks he escaped. He again volunteered and saw action where some prisoners were taken but there were no serious battles. He continued to serve until Lord Cornwallis surrendered at Yorktown, VA in October 1781. He had served on active duty about 18 months. In 1784, he submitted his claim for service and was paid twenty pounds and five shillings.

He then migrated to Georgia and settled in Wilkes County, Georgia. In almost all cases these migrations were in family groups, so we may safely assume friends and family were with them. It is a matter of record that several Smiths and Richard Downs were in the group.

Since his first child was born in 1786, he probably married in 1785. His wife was Sarah, but we are not certain of her family name. Most records indicate Downs but she could have been a Dobbs. In October 1816, Richard Downs deeded 94.5 acres to Gabriel Smith, Sr. "for affection and past services rendered." Gabriel also had neighbors named Dobbs, sold them land, and his family to this day have kept some Dobbs' papers and family records. We may never know her family name.

Gabriel applied for and received a grant of 100 acres in 1787 and about 100 acres in 1791. This land was then in Wilkes County, but as other counties were later created it fell in Elbert County and is now in Hart County, Georgia.

In 1802, Gabriel was granted 200 acres in Franklin County, Georgia and moved his family there. In 1806, Gabriel and Sarah sold what remained of their old home place. They had previously sold part of this land to Josiah and John Dobbs.

In the winter of 1833-34, Richard Smith, son of Gabriel, with his two brothers-in-law, Thomas B. Nix (wife Grace Smith)and M. William Brown (wife Mourning or Morning Smith), moved to the newly formed Carroll County. Richard and William bought land in the 9th district, and Richard lived for a long time on the "old place" sold by a A.G. Styles in 1956.

Between Nov. 11, 1836 and Dec. 14, 1836, Gabriel Smith, Sr., James C. Smith, Gabriel D. Smith, Jr., and other family members and neighbors like Trion Patterson and Beriah Hayes also moved to Carroll County from Franklin County.

William Brown sold his land to his father-in-law, Gabriel Smith, Sr. and migrated to Giles County, Tennessee. Richard Smith sold some of this land to his brother, James C. Smith, and that land is still in possession of his descendants.

Brothers Richard Smith, James Smith, and Gabriel D. Smith, Jr. were relatively well educated. They had grown up near the University of Georgia and apparently had access to schools. They each served as Justices of the Peace, which were local magistrates, for many years. They officiated at the marriage of many of their relatives. In 1840, James Smith was operating a school in the Smithfield District with 61 students attending. He also performed some of the functions of a lawyer, such as writing wills and administering estates. Ezmer Johnson has the original copy of his will which he wrote just before his death in 1846.

Richard Smith lived a long and interesting life, being well past 90 when he died. I is interesting to note that family information says he served in the war of 1812 as a substitute for his older brother, Gideon Smith Jr.

Gabriel Smith, Sr. died in the summer of 1841. He must surely be buried in the "old" Poplar Springs Cemetery (Horsley Family Cemetery). His wife Sarah was born in 1767 and died 1833 in Franklin County, Georgia. Their family record is as follows:

According to the Ancestry log from the Internet, Gabriel Smith, Sr. on Sept 30, 1837 after the death of Sarah, married Matilda Chandler in Carroll County. No other records are known at this time.

Gabriel D. Smith, Jr. married Nancy E. Cain (b. 1/21/1802 Franklin County) in 1821. Their family record is as follows: Didimmy b. 3/1/1822 Franklin Co; m. James H. Bring lunch and drinks, none will be available at church.

Leave I-20 at Exit I (Hwy. 100) go south maybe a mile or more you'll come to the Kansas Baptist Church. The dirt road leaving Hwy. 100 almost directly in front of this church leads to Poplar Springs Church.

The Horsley Cemetery a-k-a "Old Poplar Springs Cemetery" (inactive) which has recently been cleared is located about two miles down this road.

We will appreciate donations for the up keep of the cemeteries.

When I visited this cemetery, June 28 of last year, trees with a diameter of at least eight to 10 inches had been cut. Most graves are unmarked (just a stone). If any one is interested please join us and let's do something to preserve these cemeteries.

I would appreciate any information concerning the names and dates of the people buried in the Horsley cemetery.

I am particularly interested in Gabriel Smith Sr. and wife Sarah Downs Smith, their son Richard "Dickie" and wife Nancy Smith (not related) their decendants alive or deceased.

Served afterwards irregularly as a volunteer whener there was a call until Peace was proclaimed, and is clear that he served altogether about 18 months.

Is known to Thophelis Taylor of the adjoining county of Habersham who was out with him in the servee.

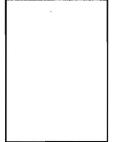

Records NOTE: Records show that Gabriel Smith was a Revolutionary Soldier who joined the Militia in N.C. at the age of 16 in Aug. 1780 and served the first three months

as a substitute for Jasper Smith. He volunteered irregularly whenever there was a call and served altogether for about 18 months. He was involved in a skirmish with the

Tories during a march to Bettises' Bridge when he taken prisoner by the Tories in the Fall of 1781, but after three weeks he made his escape from them and returned home.

He entered the service in Montgomery County, N.C. under Capt. Thomas Childs. After Capt. Childs was wounded in a skirmish with the Tories on a march to Mays Ferry they

were placed under the command of Capt. Samuel Pond. During other campaigns he served under the command of Adjutant David Jamerson & Colonel Thomas Wade.

He also volunteered under Capt. Joseph Paison & Major James Crump & Colonel Thomas Childs who had been promoted. Gabriel Smith was born in Montgomery County, N.C. on Dec. 12th, 1764.

Additional Notes: Gabriel Smith was my grt. grt. grt. grt. grandfather. It is believed that his wife was Sarah Anna Downs. I want to thank the person providing

me with new information that proves Gabriel was married to Sarah, source: from book series, "Elbert County Deed Books, 1791-1835," by Michal Martin Farmer, pub. 1997

from Elbert County Deed Book P, p. 4, a deed made on 15 Feb. 1806 from Gabriel & his wife, Sarah Smith to Hugh MacDonald for 140 acres, being a part of 2 tracts of 100 acres

each granted to the said Smith on 22 Feb. 1787. He later married Matilda Carter, nee Chandler, on Sept. 30,

1837 in Carroll County, Ga. Gabriel lived in Wilkes, Elbert, Franklin & Carroll County, Ga. at different! times. He entered the 1820 Land Lottery of Ga, drawing land in Irwin County and he also was also on a list of names of men who drew land from Capt. Walters' District in the lottery of 1825 who were Revolutionary soldiers. Gabriel also entered the 1827 land lottery, drawing land in Muscogee County, Ga. But because he did not take up the land, the land reverted back to the state. His daughter, Sarah Smith born on 02 th Sep. 1802 in Elbert County, Ga. & was my grt. grt. grt. grandmother and she married James Brown in Franklin County, Ga. on 16th Feb.1822. Sarah & James Brown removed to Randolph County, Alabama.
