March 24, 1688, Virginia, Henrico County. Godfrey, with Thomas Charles, William Hobson, Barth. Newcomb, took inventory of the estate of Thomas Newcomb. The value was 2411 lbs tobacco.

August 1, 1689, Virginia, Henrico County. Godfrey Spruill, aged about 39, William Lewis and Joshua Wynne testified as to the winners of a horse race at Malvern Hills. (Henrico Records, Virginia Historical Magazine Vol. 2, p. 296)

August 15, 1689, Virginia, Henrico County. Godfrey purchased 100 acres from Robert Sharp. (Henrico Co., VA Record Book 5, p. 564)

June 2, 1690, Virginia, Henrico County. The Henrico County minute book orphans court shows that Doctor Spruell, along with John Cannon, Philemon Childers, and Robert Sharp are appointed to appraise the estate of Herbert Powell. (You will note that Godfrey later moves to land previously owned by Mr. Powell.)

March 10, 1693, Virginia, Richmond. Joanna Spruill relinquishes her dower rights to the land Godfrey purchased from Robert Sharp. This land is then sold to John Lowry. (State Archives, Richmond, Mar 10. 1693/94)

July 2, 1694, Godfrey purchased land in Chowan Co., NC. "These may certify yt at a Crt. Holden for the precinct of Chowan ye. Second of July 1694: Godfrey Spruell proved these Eight rights as followeth: Godfrey Spruell Sen., Joana Spruell, Susanah Spruell, Ana Margeritta Spruell, Saml. Spruell, Godfrey Spruell Junr., Nicholas Phelps, Sarah Walker. Attest: Nathanl. Chevin Crk."

"Abraham Lewis of Chowan Prect., mariner with the consent of Elizabeth my now wife to Nathaniel Chevin of Chowan Prect. 6 Feb. 1699 for 15 pounds 150 arkers more or less according to the anchant bounds, at the mouth of Matoromet crick being part of a thousand arkers taken up by Thomas Horskinse and sold by him to Will Hankrock's father () and purchased by Godrey Spruell of the foresd. Hankrock and by sd. Spruell sold to us.

June 24, 1704, North Carolina. Godfrey moved his family to North Carolina. The Land Grant Office in Raleigh, North Carolina has record of Godfrey Spruill receiving 640 acres along the Scuppernong River. "Paid by Godfrey Spruill of ye county, aforesaid. Gents-- (of Henrico County, James River in Virginia. xxx one divident containing one hundred acres of landxxx bounding south upon the river beginning at ye deep bottom next the plantation late in ye possession of Herbert Powell.

It is noted in 1704, in North Carolina that Godfrey Spruill was one of the earliest physicians in North Carolina.

March 2, 1713, North Carolina, St. Pauls Parish. Memories and Records of Eastern North Carolina by Mary Weeks Lambeth notes the following: "At a Vestry meeting of St. Paul's Parish, on the 9th day of March, 1703-4, it was ordered that "Dr. Spruill be paid 5 pounds for the cure of Eleanor Adams, and on the 2nd day of March 1713-14, 12 pounds for the cure of Ebenezer Aldridge, as soon as money can be raised," by the present Church Wardens (Col. Recs.).

July 28, 1713, North Carolina. From Memories and Records - "I have not been able to find out why Dr. Godfrey Spruill was arrested on July 28, 1713 and put under bond for good behavior, but since his whole record given in the Parish Register of St. Paul's and elsewhere was an honorable and dignified one, I presume that it was for some political activity." The record says "upoon petition of John Fouree praying to put an account against Vincent White, deceased did prove the same by his oath" (Col. Rec. Vol 2. p. 403)

July 28, 1713, Godfrey Sprewell conveyed 100 acres of land to John Davenport. (Colonial Records of North Carolina, Vol. II, p. 101)

July 13, 1714, North Carolina. Dr. Godfrey Spruill and wife Joanna deeded land to son-in-law John Stuart and daughter Henrietta, 300 acres in Scuppernong.

He was elected to office on December 3, 1714 in North Carolina. He was Associate Justice under Chief Justice Christopher Gale. (Hathaway, Vol II, p. 147 & James Melson)

Oct 18, 1715, recordings of a Chowan County Court proceedings September 18, 1715 include: "Ordered that a road be cleared from Doctor (Godfrey) Spruill's to Eliza. Long's and that John Davenport Rt. Fewox, and Cuthbert Phelps lay out the Road and that all Inhabitants from Clay's Creek to John Davenport's do assist in Clearing the sd. Road, and that John Davenport be appointed overseer of the road. John Davenport, Robt. Fewox, and Cuthbert Phelps are to lay out the road." (NC Reg 1:148)

Godfrey signed a will on August 5, 1718 in North Carolina, Albermarle Province; states that he lives in North Carolina in the Province of Albemarle. It was proved in Chowan Court July 29, 1719.

In the name of God amen I GODFREY SPRUILL living in North Carolina in the Province of Albermarle being in health of body and sound of memory but considering of family of mankind do make and ordain this my last will and testament in a form following. I give and bequeath my soul unto the hand of god that gave it me and my body to the earth from whence it was taken to be buried in a Christian decent manner at the discretion of my executors hereafter named not doubting (but ??? of our Savior Jesus Christ). I shall enjoy a joyful resurrection and as to my temporal estate it hath pleased you to bless me with my funeral expenses and all my just debts being paid I give and bequeath in manner and form following that is to say first. I give and bequeath to my son SAMUEL X SPRUILL a parcel of property estimation three hundred and fifty acres more or less bounded as followeth lying at a Cypress near the eastern end of the? Branch and running thence to a tiny thicket and forming the end of the aforesaid Branch to the first outlet and along the outer Branch southerly to Great Swamp and along the Branch westerly to the end of the Buntings? along the said ?? mouth thereof and along the bay easterly to the first station to him and his heirs for ever; aforesaid land being that whereon he now lives. I give and bequeath to my son GODFREY SPRUILL three hundred fifty acres of more or less bounded as followeth being at a marked Cypress at the east end of the south banks his brother Samuel's corner free and so running

eastwardly to the Clay point to a corner tree in ?? and so running from there thence southerly to a line of marked trees to the round about branch and at round about branch to a White Ashe next to the Great Swamp and along the Great Swamp to his brother Samuel's line to the first station to him and his heirs for ever and also one Negro woman named Jenny. I give to my son JOSEPH SPRUILL that plantation whereon I now live with all the rest of the land in the neck and also a parcel of land estimation fifty acres more or less bounding on a Cypress branch westerly of the ??? ??? land a line of marked trees westwardly of the aforesaid branch to a ??? ??? from thence various courses to the first station and one Negro man named L? and one Negro man named Dolphin with all my ??? and hogs to him and his heirs for ever. I give and bequeath to my son-in-law CUTHBERT PHELPS and my daughter SUSANNAH his wife a certain tract of land of estimation three hundred acres more or less and is boundeth as followeth beginning at marked White ??? at the Back Creek's mounth and running up the Swamp to a branch eastward to Rich Level Land and along the branch to a line of marked trees ??? ??? ??? and along that line of marked trees to River ??? and from there to the first station to him and his heirs for ever. I give to my daughter SUSANNAH a gold ring of twenty shills price. I give to my daughter ANNA MARGARITTA a gold ring of twenty shills price. I give to my daughter MARY a gold ring of twenty shills price. I give to my grandson BUTTONHEAD BOUTWELL six hundred acres of land purchased by me as appearing upon record lying in the fork of Pamlico River to be to him and his heirs for ever but in default of I give to SAMUEL and his heirs and in default to ELIZABETH BOUTWELL and her heirs and on default of her I give to my grandson GODFREY SPRUILL son of SAMUEL and ELIZABETH SPRUILL to him and his heirs for ever. I nominate and appoint my son JOSEPH SPRUILL my sole and only executor of this will and testament hereby revoking all other wills of me heretofore made ratifying and confirming this as my last will and testament. Witness whereof I have here to set my hand and seal this 5 day of August 1718.

Dr. Godfrey Spruill, patriarch of the family, was born in 1650, thirteen years before King Charles issued the celebrated Carolina Charter. A tobacco planter, surgeon and patron of the sport of kings in the Cavalier colony, he had probably heard stories from ship captains who had plied the Carolina River (Albemarle Sound) in search of hides, furs and naval stores, of the inviting forests along this body's south shore. Between 1693 and 1697 he and his wife Joanna bought land in the area and moved to Carolina. They were among the section's first white settlers. The original Spruill grant included over a thousand acres of the south shore of Albemarle Sound and west side of Scuppernong River between Back Creek and Bunting Bay (now Bull's Bay). In this beautiful, primitive setting, called Heart's Delight by explorers a decade before, the Spruills set down their roots. Behind the high banks of the sound shore lay ridges cut here and there by quiet

creeks and forested with virgin timber. On this location about 1705 was founded Roundabout Plantation, the seat of the Tyrrell Spruills for the next century. Unlike many of Scuppernong's colonial land barons -- the Pettigrews, Collinses and others who held land on the South Shore but whose interests lay elsewhere -- the Spruills settled in Scuppernong and began the task of clearing and exploiting the rich dark land. Dr. Godfrey Spruill, probably one of Carolina's first medical men, became well-known throughout the struggling Albemarle Colony, being called on numerous occasions across the sound to Queen Anne's Creek, the site of present Edenton, to care for the sick. At his death the Roundabout fell to his son Samuel Spruill and then to his grandson Joseph Spruill. Around 1710 near Backlanding, the private wharves of the Roundabout, was erected Saint Paul's Chapel, one of the earliest churches in Carolina. Thirty years later Joseph Spruill gave this chapel to St. Andrew's Parish. The Roundabout and the Spruill lands at Backlanding were the center of colonial activity in Scuppernong. Here in 1746 was erected "His Majesties Warehouse" and twenty years later Benjamin Spruill invited the county court to meet at the "big house." Subsequently he gave the land for the building of the Tyrrell Courthouse at Backlanding following the outbreak of the Revolution. Here also sailing schooners docked momentarily on their voyage from Ocracoke to Edenton. For the next five generations Spruills played important roles in local as well as state religious and political life. Probably not many families in Carolina can boast such a continuous record of public service. Samuel Spruill served in the Provincial Assembly from 1754 until his death in 1760. His brother Joseph Spruill, an early vestryman of South Chowan Parish, was major of the county militia, magistrate and supervisor of "the King's high roads." He also served as sheriff and a member of the Assembly. It was his brother Colonel Hezekiah Spruill who was among Tyrrell's leaders in the Revolution. Benjamin Spruill, a member of the General Assembly, introduced the bill creating Martin County from Tyrrell in 1774. Nemeniah Spruill built the first bridge across Scuppernong River near Cool Springs (now Creswell) during early colonial times. This crossing is still called Spruill's Bridge today. It opened transportation into a new territory above Creswell and Lake Phelps to settlers. Two Spruills, Joseph and Benjamin, were members of the First and Second Provincial Congresses in the turbulent opening days of the Revolution. Joseph Spruill was a signer of the Halifax Resolves and was appointed a major in the battalion being gathered in Tyrrell at Lee's Mill under the leadership of Colonel Edward Buncombe. Hezekiah Spruill and Stephen Lee were appointed by the Second Provincial Congress to "receive, procure and purchase firearms for the use of the troops and to receive, maintain and repair all swords, dirks, pistols and other implements of war which have been taken by the Tories." Like many of the hard-pressed farmers of the southern Albemarle many Spruills migrated to the Deep South and to the Mid-West. Today seldom a week passes that the Tyrrell Register of Deeds office does not receive inquiries from genealogists and researchers about this now fairly widespread name. Many take the time and expense to come to Columbia to search the county's colonial records for information about this lost generation of early Carolinians. John W. Melson of Columbia, who has for several years done research on the history of the Spruills, has uncovered most of the information known today about the family. From 1750 until 1860 there was hardly a North Carolina General Assembly without a Spruill representing Tyrrell or neighboring Washington County. The main branch of the Spruill family, established in Alligator by Colonel Hezekiah, remained on the north shore until the latter part of the 1800's when the place was sold and gradually passed away, much of it reclaimed by the dense forests. Only a few Tyrrell countians now bear this old name.

ITEM I give and bequeath unto RUTH my Dear beloved wife all his goods & chattels that she brought on my premises when we was married also fifty acres of land lying the north side of the creek where I now live, adjoining land belonging to WILLIAM LORD and the MITCHELLS during her life or widowhood at which time the said Land is to be Equally Divided amongest my children,

ITEM I give unto my sons THOMAS & GABRIEL at the end of six years a good horse to each of them one good feather bed and furniture to each of them & one good cow a peace, and what is left of my Estate it is my will it should be sold on a credit of two years and the money Equally Divided between my twelve children (viz) WILLIAM, GEORGE, LUKE, SIMEON, JOHN, POLLY, SAMUEL, JEPTOR, NANCY, SALLY, THOMAS & GABRIEL. also it is my will that the lawfill heirs of my Daughter PEGGY should have a Equal share of the Money that is Raised out of my Estate with my twelve children, (viz) her heirs to have one thirteenth part of my Estate.

I likewise constitute and appoint my son SIMEON and my son in law WILLIAM WELDON my only and sole Executors of this my last will & testament and I do hereby utterly disallow revoke and disannul all and every other former will and Executors by me in any wise before this time appointed in witness where of I have set my Hand & Seal this day and Date above written. Signed & sealed in presents of us

He also received a grant of 640 acres on Scuppernong River in Terrell County NC on 6/25/1704. He was one of the earliest physicians in North Carolina. Gabriel Spruill is thought to be the earliest Spruill living in Carroll County. He was born around 1808 in Abbeville South Carolina and married Susan Mann on 11/20/1834. They came to Carroll County in 1844-45. Several Spruills fought in the Revolutionary and Civil Wars. Gabriel had five sons who fought for the Confederacy, only one survived.
